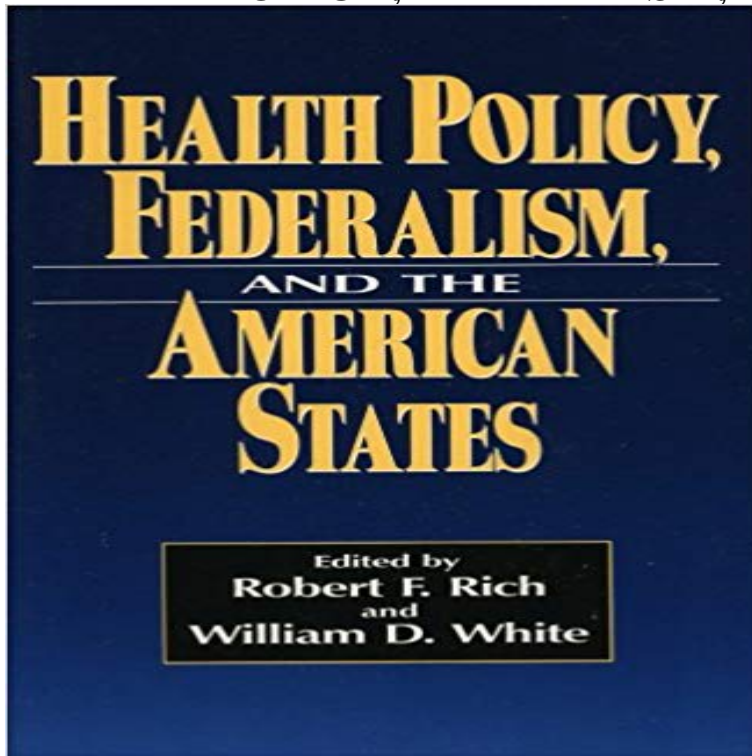


## HEALTH POLICY, FEDERALISM, AND THE AMERI
