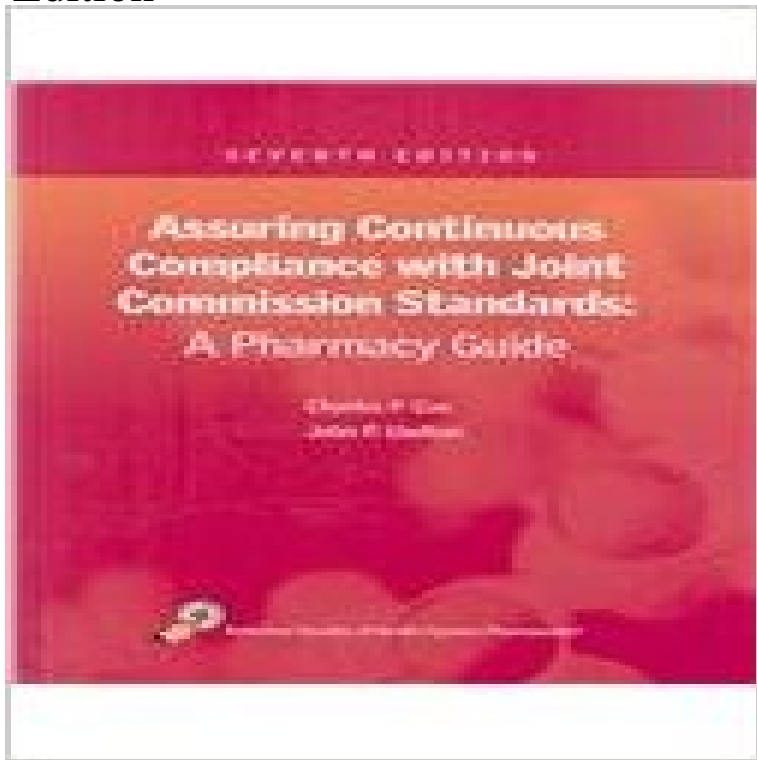


Assuring Continuous Compliance with Joint Commission Standards, 7th Edition
