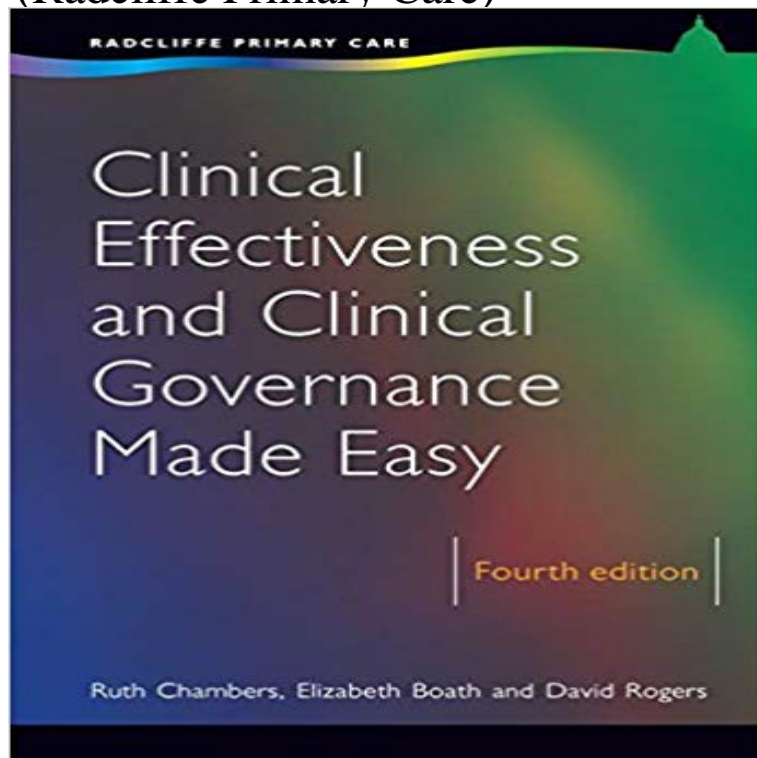


## Clinical Effectiveness and Clinical Governance Made Easy, 4th Edition (Radcliffe Primary Care)
