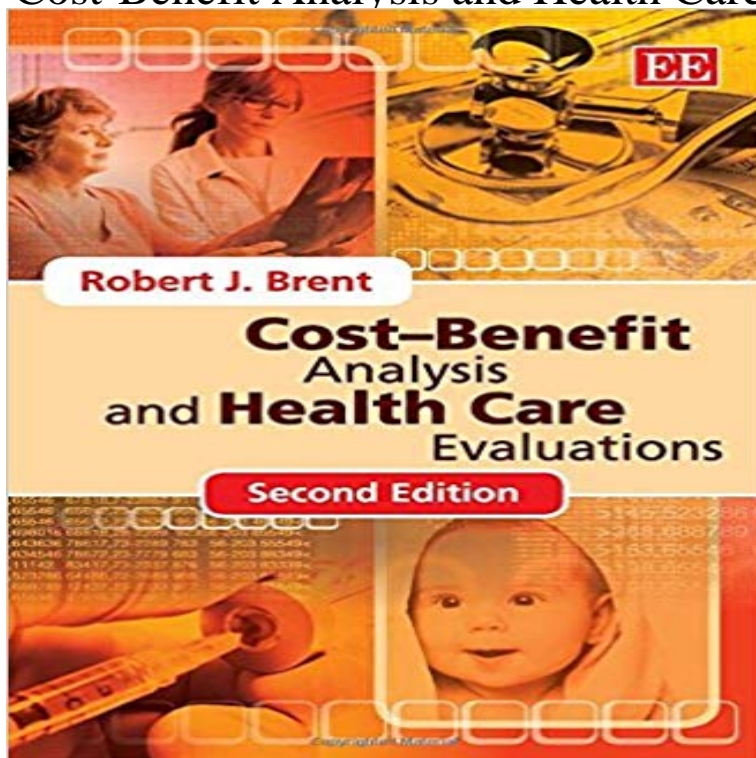


Cost-Benefit Analysis and Health Care Evaluations, Second Edition
