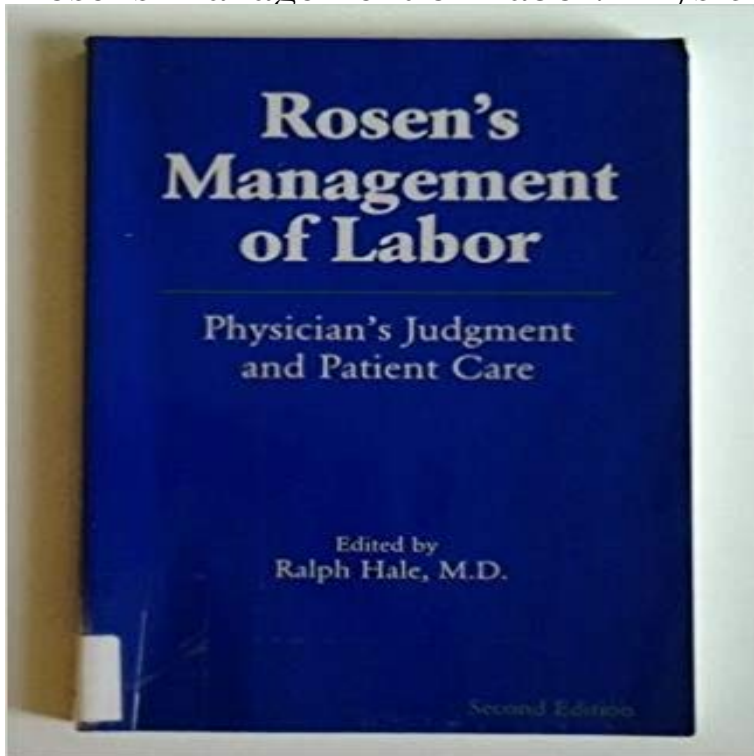


Rosens Management of Labor: Physicians Judgment and Patient Care

In this second edition, the text has been updated to reflect the changes that have occurred since the first edition was published, with the addition of several new chapters, but the original philosophy of Dr Rosen has been maintained. The book will prove an invaluable support to the trainee and practising obstetrician, particularly during difficult moments in patient care such as fetal stress, breech delivery and the use of forceps.
