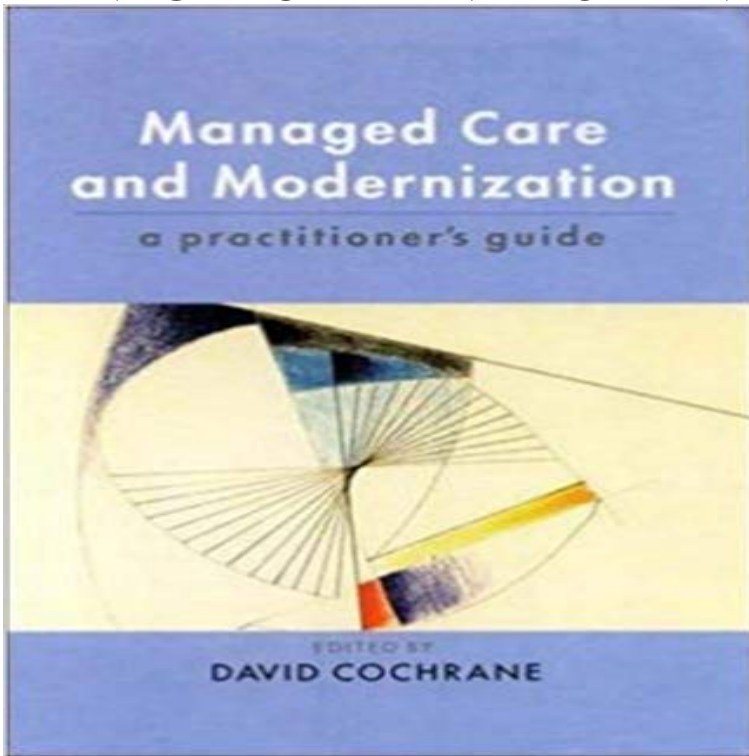


# MANAGED CARE AND MODERNIZATION
