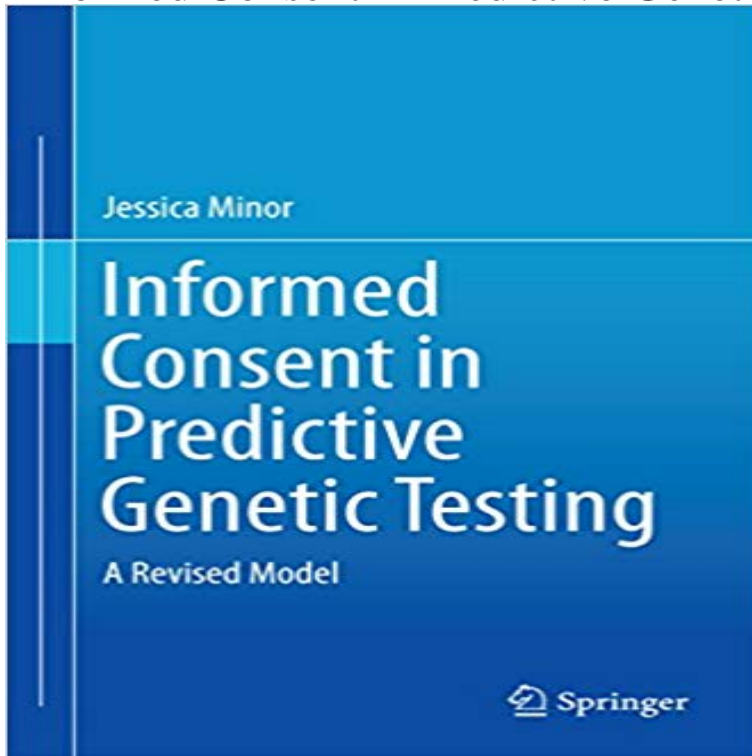


# Informed Consent in Predictive Genetic Testing: A Revised Model
