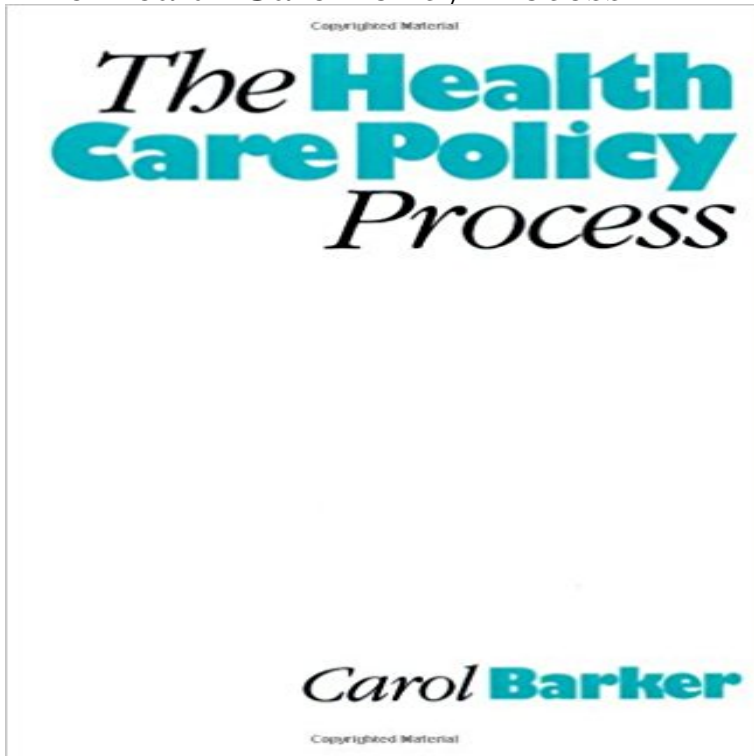


The Health Care Policy Process
