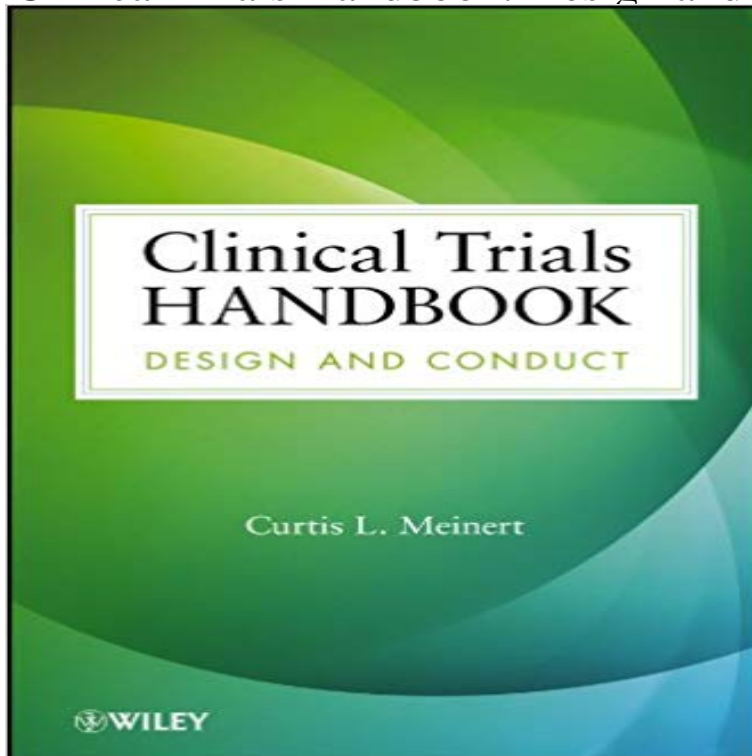


Clinical Trials Handbook: Design and Conduct
