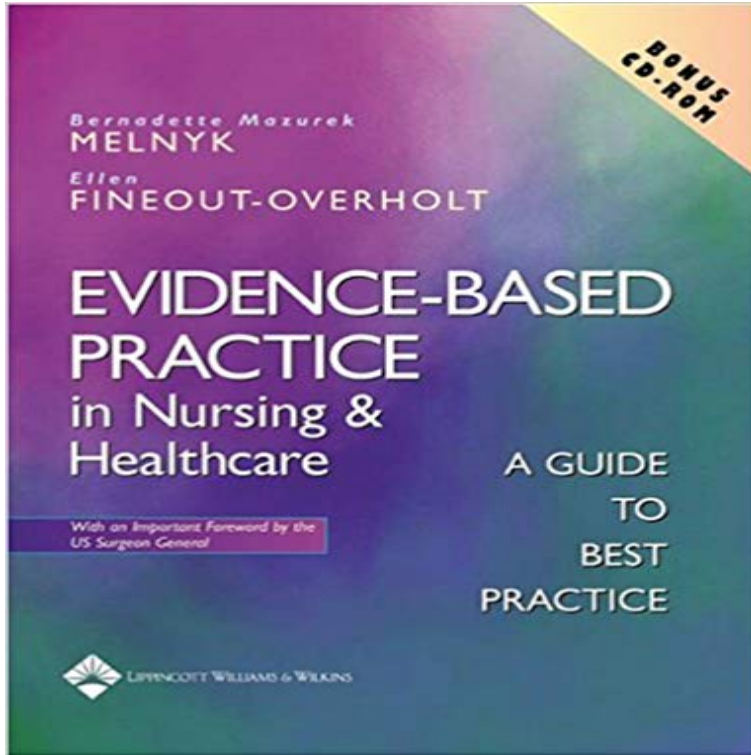


Evidence-Based Practice in Nursing and Healthcare: A Guide to Best Practice
