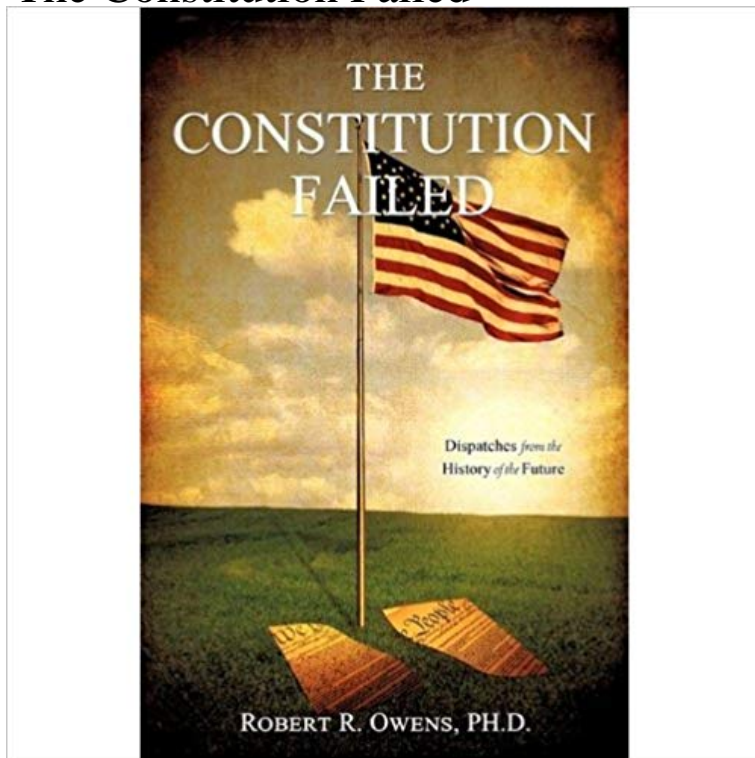


The Constitution Failed
