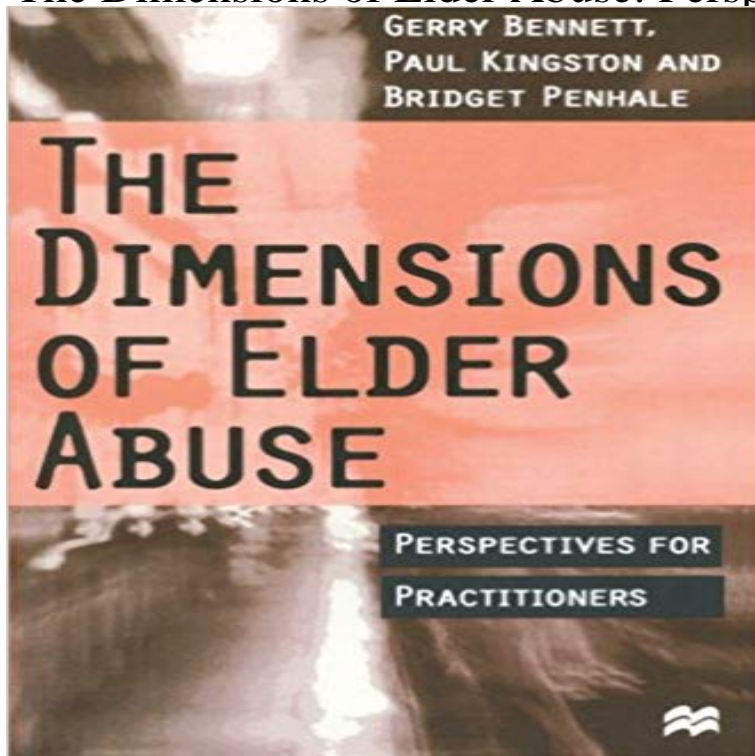


The Dimensions of Elder Abuse: Perspectives for Practitioners
