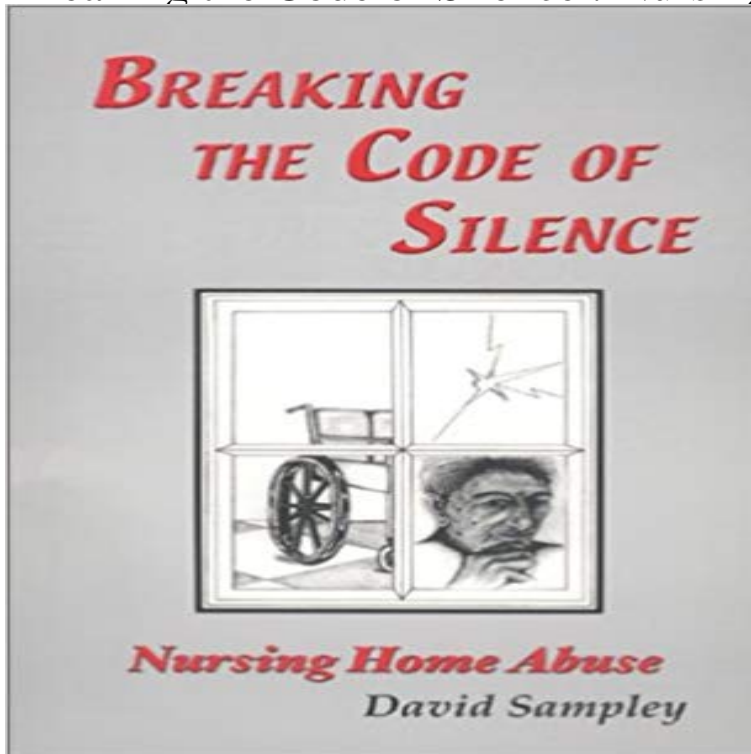


Breaking the Code of Silence : Nursing Home Abuse
